Transparent application tape based on a single sided embossed polypropylene film, with excellent flatness. It is dimensionally stable, easy to unroll position and will not stretch or curl. Suitable for transferring self- adhesive signs, logos and lettering produced from cast or calendared CAD/CAM plotter films with matt and brilliant surface; especially to be emphasized are the following properties:

- As the tape does not curl, wrinkling is avoided during lamination of large lettering. The film adjusts perfectly to the surface.
- The plasticizer resistant adhesive guarantees a strong initial tack to all types of vinyl films. The application tape is easily removed without leaving any residue, even after being left for a period of time.
- Suitable for wet application.
- The film can be torn transversally, which facilitates handling.
- The embossed surface allows the film to be easily unrolled without any electrostatic charging.
